#### 9. PLANNING APPLICATIONS

P0852/18/FUL. Brownings Farm, Millend, Blakeney. Erection of a replacement dwelling with annexe accommodation for relative, x2 two bedroom holiday lets, x1 three bedroom let, stables, agricultural storage barn incorporating bee house plus office/farm store and creation of external courtyard with associated works. Demolition of existing dwelling, derelict agricultural barns, stables and garages. Councillors decided to defer comments again because further details regarding drainage, ecology, access and waste collection are still awaited.

P1388/18/FUL. Birmingham House, High Street, Blakeney. Change of use of front ground floor rooms from commercial back to original use of residential. No observations or objections.

P1622/18/FUL. Chapel House, Brains Green. Erection of a replacement dwelling with associated works. Demolition of existing dwelling (Resubmission). Revised Scheme. Councillors are disappointed because they agreed to the demolition of the building on the premise that it was going to be rebuilt as per the original. They feel that they have been misled. However they have no objections to the application.

P1768/18/TPO. Old Station Close, Blakeney. Works to trees covered by A1 and A2 of TPO80 as detailed in application form and agents e mail of 7.11.18. No clear plans. Cllrs. would like a site meeting to clarify what they intend to do with the trees between site and School/houses in Butlers Mead which are out of control and a danger to school children and residents/properties in Butlers Mead.

#### 14. FUTURE ACTION REGARDING BLAKENEY TOILETS

It was agreed that for the time being the services should be maintained to the toilets. Electricity is required for the defibrillator. Attempts will be made to obtain up to date meter readings.

#### 15. OUTSTANDING FOOTPATH ISSUES

A new footbridge has been installed over Soudley Brook on the footpath leading from All Saints to the Recreation Ground in Blakeney. A complaint has been received regarding the track from the reservoir on Blakeney Hill towards the Lodge. The person was referred to the Forestry Commission.

The dumping of a pile of asphalt on a track at the top of Clarkes Lane, Blakeney was reported and there are now cars parked there which are causing a traffic hazard. Cllr Bullock agreed to investigate.

#### 16. PLANS FOR HANGING BASKETS, BLAKENEY FOR NEXT YEAR

It was agreed that permission should be sought for four further hanging baskets in Blakeney. Rooftop Housing has agreed to one being placed on their land opposite the British Legion. The Clerk was asked to make a provisional booking for 10 baskets, whilst additional sites are investigated.

#### 18. MATTERS RELATING TO THE CEMETERY

Cllr Allen produced a revised list of charges. It was proposed by Cllr Marshall, seconded by Cllr Cotton and agreed by the meeting, to apply from 1.4.19. See attached.

It was agreed that a meeting be arranged for Cllr's to visit the cemetery to look at the possibility of providing a designated are for the dumping of spoil and assessing the degree of risk on the bank, as identified in the annual Risk Assessment. Deferred to next meeting.

#### 19. OTHER MATTERS CONCERNING THE COUNCIL

Cllr. Blake informed the meeting that he laid a wreath, on behalf of the Parish Council, at the Blakeney War Memorial on 11.11.18.

Cllr Fellows agreed to pass on a number of highway issues to Mr Watkins, County Highways.

Some of the problems regarding undergrowth encroaching on the highway on Blakeney Hill have been dealt with. Two 'pinch points' remain.

Timing/dates for meetings in 2019 to be discussed at next meeting.

Cllr Ware has produced some speed sign data and will continue to collect over a longer period.
