Minutes of the Parish Council Meeting held on 16<sup>th</sup> December, 2024 at Blakeney Youth Centre at 7.00 p.m.

#### 145. APOLOGIES

Apologies for absence received from Cllr. Scott and District Cllr. Burton. were accepted.

#### 146. DECLARATIONS OF INTEREST

A declaration of interest was made by Cllr. Hoyland in relation to the item 155.2/Hedge laying quotes.

#### 147. DISPENSATIONS

## 149. MINUTES OF PREVIOUS MEETING

<u>It was resolved</u> to adopt the minutes of the meeting held on 18<sup>th</sup> November 2024 as an accurate record.

#### 150. MATTERS ARISING

Information from the Clerk relating to matters arising from the minutes of the last meeting and other items <u>was noted.</u>

## 151. REPORT FROM COUNTY COUNCILLOR

County Cllr. Hoyland's report circulated before the meeting was noted, in particular:

- a) that there had been a large number of e-mails regarding roadworks planned before the year end.
- b) details have been released regarding the County Council's spending plans for 2025/26.
- c) Cllr. Fellows expressed concern that despite a weather warning for rain and freezing temperatures, the A48 had not been gritted leading to a number of accidents.
- d) Cllr. Bullock reported that the road by Netherhall Farm, Awre Road was dangerous in frosty weather and had been reported several times.

## 152. DISTRICT COUNCILLOR REPORT

District Cllr. Burton's report which was circulated prior to the meeting <u>was noted</u>. Access to the toilet block was discussed further and it was concluded that since this was not unencumbered, it would not be possible to reach an agreement with the landowners. Furthermore, as the Lessee, it was not for the Parish Council to negotiate in this matter. It was the responsibility of the Forest of Dean District Council. It is the opinion of the District Council that the toilets' access is unimpeded as observed a number of years ago. The Parish Council dispute this and offer to visit

the site with a member of the District Council Estates Team to see the current situation.

### 153. PLANNING – FOREST OF DEAN DISTRICT COUNCIL

# 153.1 P1333/24/FUL - Old Church Rooms, Church Way, Blakeney

Variation of Condition 1 (installation of screens within 3 months of permission) relating to planning permission P0938/24/NONMAT to extend the timescale for the implementation of the privacy screens by an additional 5 months. No observations or objections.

## 153.2 P1477/24/FUL - The Old Inn, Two Bridges, Blakeney

Erection of two storey side extension, single storey side extension and replacement garage, demolition of existing garage and associated work. No observations or objections.

## 154. CORRESPONDENCE REQUIRING ACTION

- **154.1 FoDDC Car Park Proposed Car Charger Installations** —correspondence regarding the installation of 4 electric vehicle charging stations in the Butlers Mead car park was considered. The following points were made:
  - a) Who are these trickle charging points aimed at?
  - b) The car park is busy and well used and so to remove 4 parking spaces would cause major problems for local residents.
  - c) A proper plan is required.
  - d) It is important that this installation does not clash with that of the bike shelter.
  - e) 1 x rapid charging point would be far better than the 4 proposed.
- **154.2 WWT to Restore Saltmarsh on Awre Peninsula** the press release received and its tone was noted. Further discussions would need to take place regarding the Severn Way footpath, a transportation plan for the earthworks materials together with car parking and access for the public.

## 155.2 DRAFT BUDGET - 2025/2026

The financial position to date, the predicted outcome at year end and the draft budget for 2025/2026 were received. Following consideration, it was agreed that the Clerk should re-work the budget to include an increase in precept of 10%. This would be the first increase for 10 years but was necessary owing to the increase in cemetery and general maintenance costs. The revised budget to be presented to the January meeting to approve the precept.

Cllr. Fellows reported that GRCC had contacted a number of Housing Associations and Wyedean Housing were interested. He had asked GRCC for an update and an indication of timescales.

## 157. GRASS CUTTING CONTRACT 2025 - 2027

<u>It was agreed</u>, that apart from dates, the current tender specification was correct. The Clerk outlined the key dates for advertising the contract as follows:

- b) 30<sup>th</sup> January deadline for replies.
- c) w/c 3<sup>rd</sup> February tenders to be opened.
- d) February meeting decision.

## 158. LEAD COUNCILLOR REPORTS

# 158.1 Highways & Parish Council Land

- a) A question was raised regarding a road closure, and what it was for, starting on 24<sup>th</sup> March for 5 days between the A48 and the junction with Branches Road, Awre? Cllr. Hoyland confirmed that it was to do with drainage and had the backing of the local farmer.
- b) Blakeney Hill Hedge cutting. Yet again, nothing has been done and in addition to inconveniencing pedestrians and drivers, delivery companies including oil and gas are refusing to enter the area. Cllr. Hoyland said that she would arrange a meeting with Nathan Choat and Cllr. Fellows to walk the lanes to emphasise the long overdue, urgent work needed.
- c) It was suggested that perhaps the Parish Council could organise a contractor with a flail hedgecutter to carry out the work.

## 158.2 Footpaths/Public Rights of Way (PROW)

- a) Cllr. Hoyland said that she would contact Jeff Wheeler regarding the footpath sign, near the New Road junction with the A48, which had been hit and damaged by a truck.
- b) Also, the stile on Hitchings was mentioned as being in need of repair or replacement with a kissing gate.
- **158.3 Cemetery & Grass Cutting** noted that the pre-Winter but had been carried out and invoiced. A quotation was awaited for the additional work detailed at the last meeting.
- **158.4 Eel Pass** Clerk to contact the contractor to arrange the cleaning of the eel pass before the end of February. It was suggested that a 'before' photograph is taken and that the Council is informed when the cleaning is to take place.
